Job Title: Visitation Guide

Number of openings: 14

Purpose:

JUST is seeking out volunteers who would like to support families and friends of inmates during visitation hours. We believe that by providing support to families and friends of inmates, the visitation process will be made less stressful. In addition, by communicating directly with these individuals, we can better establish the needs of an inmate's family and friends

Location/Time: DuPage County Jail

During visitation hours - - 7 possible time slots.

Key Responsibilities:

- Be present in visitation to assist family and friends of inmates with both emotional support and additional information regarding the jail and JUST programs
- Establish a friendly relationship with family and friends of inmates
- Provide support to families and friends of inmates
- Discover the needs of families and friends of inmates in an effort to better assist them
- Work with and report to Chaplain
- Be available for emotional and spiritual needs

Qualifications:

- Recommended (but not required) prior experience working in the jail - have an understanding of the jail's policies and procedures
- Have an outgoing personality and positive outlook
- Be willing to engage with family and friends of inmates
- Ability to work with individuals from a variety of backgrounds
- Ability to remain non-judgmental
